Sealed Tenders in prescribed format are invited from agencies having experience and expertise in carrying out the job of Preparation of “**Ground Water Management Plan**” along with Ground Water Quality Analysis Report, Rain Water Harvesting Proposal, Flow Chart of Water Balance, Effluent Discharge Treatment Plan etc. and submission of Online application thereupon with due recommendation of SPCB, Odisha and obtaining approval/NOC from the Central Ground Water Authority/Board, Ministry of Water Resources, River Development and Ganga Rejuvenation for abstract & use of ground water in BSLC M. L. areas.

1. General Description of Scope of Work:

Preparation of **Ground Water Management Plan** along with Ground Water Quality Analysis Report, Rain Water Harvesting Proposal, Flow Chart of Water Balance, Effluent Discharge Treatment Plan etc. and submission of Online application thereupon with due recommendation of SPCB, Odisha and obtaining approval/NOC from the Central Ground Water Authority/Board, Ministry of Water Resources, River Development and Ganga Rejuvenation for abstract & use of ground water in respect of our Mining Lease namely.

2. Price Bid:-

Bidders are requested to quote their price for NOC of Ground water job in the format given in **Annexure-I** i.e. price bid (**part-II**)

3. Tender Submission:-

A non- transferable tender documents can be obtained from The Dy. Manager (Finance), The Bisra Stone Lime Company Limited, Birmiritrapur, Dist: Sundargarh, Odisha, Pin: 770033 on payment of **Rs.590/-[Rupees five hundred ninety only]** in cash on any working day on or before 12.00 Noon dated 18.03.2021 to 25.03.2021 during Office hours and can be also downloaded from the website **www.birdgroup.co.in**

The downloaded Tender documents should be submitted along with a Demand Draft of Rs.590/- (Rupees five hundred ninety only) in favour of “The Bisra Stone Lime Company Limited” payable at Birmiritrapur towards cost of the same. In case of downloaded tender, the bidder has to submit an undertaking on the company’s letter head that no amendment have been made in the tender document downloaded from company’s website, at the time of submission of the tender document. In case of non submission of cost of tender document, the tender shall be liable for rejection.

3.1. EARNEST MONEY DEPOSIT:

Each Tender must be accompanied with the non interest bearing pre-bid Earnest Money Deposit (as prescribed) of **Rs.5,000/- (Rupees five thousand only)** in shape of Bank draft/Pay order drawn on any Schedule/Nationalized Bank in favour of “The Bisra Stone Lime Co. Ltd.” payable at Birmatrapur. Name of the remitter shall be mentioned in the DD/PO. Tender without prescribed earnest money shall be liable for rejection. The earnest money of the successful bidder shall be converted into security deposit which bears no interest shall be refunded within 90 days from the date of completion of date of job.

Note: - Earnest money of the disqualified/unsuccessful bidder will be refunded after award of the contract.

3.2. OPENING OF TENDER:

The Tender document shall be submitted in two parts i.e. Part-I Techno Commercial Bid and Part-II Price Bid in separate sealed envelopes. Both Techno-commercial bid and Price bid shall be sealed in separate envelopes with complete tender details super scribed on both the envelopes and clearly identifying the techno-commercial bid and price-bid on the respective envelopes. Both the bid shall be kept in another sealed envelope supercribing the Tender No. and Date.

4.2.(a) The Part-I, Techno Commercial Bid shall be opened in the presence of the bidders or their accredited representative after 3.30 P.M on 25.03.2021 in the Conference Hall of the Company

4.2.(b) Part –II i.e. Price Bid of the Agency, whose Techno Commercial Bid are found acceptable, shall be opened on a fixed date & time, which will be intimated to the bidders separately after opening and finalization of Techno Commercial Bid. In this respect, the decision of the company shall be final and binding on the tenderer.

Note: - (Bids received after 3.30 P.M. will be rejected.)

4.2.(c) The company shall not be liable for any delay in submission of the tender documents due to postal delay and no extension of date for tender submission / tender opening shall be given for this reason.

4.2.(d) The company reserves the right not to accept the lowest offer. The company also reserves the right to cancel the tender and in such an event no claim of any tenderer for such a decision by the company shall be entertained.

4.2.(e) The validity of the offer shall be for 120 days from the date of opening of the Techno Commercial Bid.

4.2.(f) Interested Parties are advised to visit the site and familiarize themselves with the site conditions, concerned areas and go through the attached terms & conditions of the tender document before submission of tender documents.

TERMS AND CONDITIONS

1. SCOPE OF WORK

Preparation of “**Ground Water Management Plan**” along with Ground Water Quality Analysis Report, Rain Water Harvesting Proposal, Flow Chart of Water Balance, Effluent Discharge Treatment Plan etc. and submission of Online application thereupon with due recommendation of SPCB, Odisha and obtaining approval/NOC from the Central Ground Water Authority/Board, Ministry of Water Resources, River Development and Ganga Rejuvenation at BISRA STONE LIME COMPANY LIMITED, Birmitrapur.

- (ix) The online processing fees will be paid by the Agency

2. CONTRACT PERIOD: The period of contract will be 03 months from the date of award of Lol/ work order.

- 2.1. Online application is to be made within 01(One) months w.e.f. the date of award of job.
- 2.2. Obtaining NOC within 03 (three) months w.e.f. the date of award of job.
- 2.3. No extension of time period for obtaining NOC shall be entertained without sufficient justification to the satisfaction of the management (BSLC) that the delay is beyond the control of the consultant.

3. LOCATION OF MONITORING STATIONS:

At our mines of M/S BISRA STONE LIME COMPANY LIMITED, Birmitrapur, as core zone and Collection of Basic Hydro-geological information for core and 10 km. buffer zone of mining lease.

4. ELIGIBILITY CONDITION:

A bidder shall qualify technically subject to fulfillment of following condition. The bidder must submit the documentary evidence along with the technical bid in support of the following:-

- (i) The Agency must be having valid accredited under CGWA (**Central Ground Water Authority**). OR having collaboration with CGWA accredited institution and having NABL accredited laboratories.
- (ii) Agency should have completed successfully at least one project in last 03 **years i.e. from 2017-18 to 2019-20** for "Preparation of "Ground Water Management Plan" and obtaining approval/NOC from the Central Ground Water Authority/Board. Copies of completion certificates/approval letter from the authority(s) in this regard will be submitted.
- (iii) The EMD of Rs.5,000/- in shape of DD/Pay order/Bank guarantee from any Nationalised bank payable in favour of "The Bisra Stone Lime Company Limited";at Birmitrapur, to be enclosed.
- (iv) Submission of Proof of payment made to BSLC towards cost of tender Document of Rs.590/-.
- (v) Agency should submit copy of PAN card, Organizational Structure & copy of GST Registration No. etc.
- (vi) Agency should submit documentary evidences as proof of Average financial annual turnover of minimum 1.50 lakh during last three years ending 31.03.2019. Copy of balance sheet, P/L Account and Annual Return towards proof of annual turnover shall be submitted to the effect.

(b) Other Criteria as proof of technical competency & credential of the Agency(s):

- (i) Status of the bidder should be submitted as regards:-
 - a. Partnership Deed in case of a Partnership firm.
 - b. Memorandum & Articles of Associations in case of a Company.
 - c. Proprietorship certificate in case of proprietorship firm.
 - d. MSME
 - e. Start up Business Unit
- (ii) Annual turnover of the agency
- (iii) An undertaking, in Company/Firm's Letter Head is required regarding that the party is not blacklisted by any PSU & BSLC at any point of time.
- (iv) A declaration is to be submitted that the bidder has carefully read all tender terms & conditions of the tender document.

5. SECURITY DEPOSIT (SD):

The earnest money deposit of successful tenderer shall be converted into security deposit and shall

not bear any interest. The security deposit will be released on completion of the work.

6. EVALUATION OF THE BIDS:

- i) **The Part-I Techno Commercial Bid:** Parties, who will fulfill all requisite conditions of eligibility clause of Chapter-II of this document will be considered as techno commercially qualified and may be considered for Part-II Price Bid.
- ii) The Price Bid of techno commercially qualified bidders shall be evaluated in the light of L₁ on the basis.
- iii) In case there is any discrepancy between figures and words, then the amount quoted in words will be considered for evaluation.

7. AWARD OF CONTRACT

- 7.1. The company reserves the right to accept or reject any or all tenders without assigning any reason thereof.
- 7.2. Award of contract shall be made at the absolute discretion of BSLC. The company reserves the right to reject any part or whole of the tender without assigning any reason whatsoever. For such cancellation the tenderer shall not be entitled to claim any cost, charges, expenses incidental to or incurred by him through or in connection with the preparation and submission without assigning any reason whatsoever.
- 7.3. BSLC also reserves the right not to accept the lowest offer.
- 7.4. BSLC shall not be liable for any delay in receipt of the tender document by the tenderer due to postal delay and no extension of time to the date of tender opening shall be given for this reason.
- 7.5. The award of contract will be based on the amount of total work in lowest rate in price bid. (Part-II).

8. PAYMENT & SETTLEMENT OF BILLS:

Payment shall be made on the basis of the rate finalised in the tender. The agency needs to submit the details of Bank A/c, Branch, IFSC code, etc for enabling BSLC to release the payment through RTGS in the following manner.

- 1) 40% of the total job value shall be paid against successful completion of online application
- 2) 60% of the payment shall be released to the agency after obtaining approval/NOC of ground water for use in respect of mining lease of BSLC

9. LIQUIDATED DAMAGE:

In the event of agency's failure to carry out the assigned job within the stipulated period or within such extended period, BSLC will have the right to impose a penalty @ Rs.500/- per day of such failure.

If the delay is found to be for reasons, which are beyond the control of the tenderer, the penalty can be waived by Business head of BSLC on receipt of request from tenderer and recommendation of respective departments. The Business Head if convinced can extend the period of contract for such period as found reasonable and thereafter may terminate the contract.

BSLC shall have the right to get the left-over job done by other agency and the additional cost, if any, will be debited to their account proportionately in respect of corresponding job.

The EMD/SD of the agency shall be liable to be forfeited in such case of failure to complete the job within stipulated period or within such extended period (as approved by the Business Head).

10. TAX DEDUCTED AT SOURCES:

Income Tax and other taxes including surcharge and cess as applicable shall be deducted at source at the rate prescribed in the Income Tax act and/or other Act from the gross value of each bill.

CHAPTER-III

GENERAL CONDITION

1. DEFINITIONS:

- a. **Tenderer/Bidder** : Tenderer / Bidder means a person, Society, Firm, or Company willing to participate by accepting terms and conditions given in the tender documents;
- b. **Tender**: Tender means the work to be performed according to the tender documents (both technical and commercial) submitted by the tenderer for consideration of BSLC;
- c. **Name of the Tender**: Name of the Tender means the work to be performed by the tenderer;
- d. **Techno-Commercial Bid**: Techno-Commercial Bid means documents regarding eligibility condition as stipulated in the tender documents for qualifying the Tenderer for consideration of the Price Bid;
- e. **Scheduled Rate**: Scheduled Rate means the rate quoted by the tenderer in the prescribed Price Bid Format;
- f. **Price Bid**: Price Bid means the document containing the scheduled rate to be considered for the purpose of evaluation and award of contract.
- g. **Contractor**: Contractor means the person or society, firm, Company whose tender has been accepted by the BSLC;
- h. **BSLC**: BSLC means “The Bisra Stone Lime Company Limited” A Company incorporated in India and having its registered office at **Plot No.2132/5131/5161(Part), Jayadev Nagar, Nageswar Tangi, Bhubaneswar - 751002**, which is alternatively used as the “Company”.
- i. **Employer**: Employer means BSLC
- j. **Competent Authority**: Competent Authority means Managing Director (MD) or any designated officer nominated by the MD.
- k. **Business Head**): Unit Head of BSLC at Birmitrapur.
- l. **Taxes**: Taxes means Income Tax, Surcharge, GST, and any other Tax, Levy, Fees, Cess imposed by the Government from time to time.

2. OTHER CONDITIONS:

- 2.1. The Agency shall have to make his own arrangement for traveling, boarding, lodging etc. to the Site including visit to the connecting office.
- 2.2. The company shall provide accommodation.
- 2.3. BSLC reserves the right not to accept the lowest offer.
- 2.4. The company reserves the right to accept or reject any or all tenders or distribute the work amongst different Tenderer without assigning any reason thereof.
- 2.5. BSLC shall not be liable for any delay in receipt of the tender document by the Tenderers due to postal delay and no extension of time to the date of tender opening shall be given for this reason.
- 2.6. In case the tenderer declines to take up the work or fails to cope up with the progress of work, BSLC reserves the right to terminate the contract and forfeit the earnest money of the agency and the cost of the work he/she have done by that time and work may be rescinded.
- 2.7. The agency shall submit the quarterly monitoring report within 7 days succeeding each quarter in triplicate.
- 2.8. If it comes to the notice of the Employer/BSLC at any stage right from request for enlistment/ tender document that any of the certificates/documents submitted by

applicants for enlistment or by Tenderers are found to be false/fake/doctored, the party will be debarred from participation in all the Employer's tenders for a period of five (5) years including termination of contract, if awarded. EMD/Security Deposit etc., given by them, if any, will be forfeited. The Contractor in such cases shall make good to the Employer any loss or damage resulting from such termination. Contracts in operation anywhere in the Employer will also be terminated with attendant fall outs like forfeiture of EMD/Security Deposit, if any, and recovery of Risk and Cost Charges etc. Decision of the Employer will be final and binding.

- 2.9. Failure to execute the work after LOI/ work order is given will make the party liable for debarring for a period (2) two years.

3. LEGAL & MISCELLANEOUS OBLIGATION:

- 3.1. Detailed lists of Technical, Managerial and Supervisory Personnel with name, age, qualification and experience including Directors in respect of Company and Partners in respect of Firm.
- 3.2. No part of the contract shall be sublet without written permission of the Business Head of the company or transfer is made by Power of Attorney authorizing others to receive payment on the agency's behalf.
- 3.3. With regard to execution of this work, the agency shall abide by the direction of Geology & Environment department.
- 3.4. Each page of the tender schedule must be signed by the tenderer as acceptance of the terms and condition before submission, otherwise the tender will be treated as invalid.
- 3.5. In the event of agency's failure to fulfill the contract terms for execution of work therein, the company reserves the right to terminate the contract by giving 30 (thirty) days' notice and to have the contractual obligations carried out by alternative arrangement and consequential loss suffered thereby shall be borne by the agency.
- 3.6. Submission of any forged document will attract legal action including rejection of tender or cancellation of contract at the risk and cost of the agency if awarded.
- 3.7. The Agency shall have no claim whatsoever against the company for any loss / damage caused to it by statutory action or any cause of whatsoever nature or description beyond the control of the company.

4. FORCE MAJEURE

- 4.1. The Contractor shall have no claim whatsoever against the Company for any loss/damage caused to the contractor by reason of war, riot, commotion, disturbance, pestilence/epidemic sickness, strike, lock-out, earthquake, fire, storm, flood, explosion, any change in the nature of deposits, break down at plant or machinery for whatever reason, failure/restriction of electrical or other power. Act of God, scarcity/insufficiency of supply of wagons by Railways, preventing or delaying the loading of ores, Government requisition, Govt. order or statutory action of any Govt. agency or any cause of whatever nature or description beyond the control of the Company.
- 4.2. Either party affected by the force majeure will provide notice of happenings of any such eventuality to the other party within 7 days from the date of occurrence and failure will not give any benefit.
- 4.3. The Contractor shall resume the work as soon as practicable after such eventuality has ceased to exist of which the Company shall be sole judge.
- 4.4. If the performance in whole or part of any term/obligation under the contract is prevented or delayed by any such eventuality for a period exceeding seven days of escalation of above events the contract may be terminated at the discretion of the Company.

5. DAMAGE TO BSLC PROPERTIES

The Tenderer will be fully responsible for any loss/damage that may be caused to the premises, equipment, machinery, and other installations of BSLC in the course of removing the material bought by the buyer. The buyer will be fully responsible to reimburse all damages as may be determined by BSLC.

6. ILLEGAL GRATIFICATION

Any bribes, commission, gifts or advantage given, promised or offered by or on behalf of the Tenderer /customer or his partner, agent, or servant to any officer, servant, representative, or agent of the Company in relation to the obtaining or to the execution of this or any other contract with the Company for showing or for bearing to show favor or disfavor to any person shall be resulting into the cancellation of this contract.

7. DEVIATION:-

Deviations sought by the Tenderer whether they are commercial or technical must only be given within the schedule prescribed. Any willful attempt by the Tenderers to camouflage the deviation, by giving them in the covering letter or in any other documents, than the prescribed schedules, may render the bid itself non-responsive and liable for rejection. Any incomplete tender or conditional tender received shall also be liable for rejection.

8. RISK PURCHASE:

In the event of failure to fulfill the contractual obligations as per Work order/agreement of contract, the company reserves the right to make the contractual obligations carried out by alternative arrangement at the sole risk and cost of the contractor and the company shall recover from the agency any additional cost involved therein. The EMD/Security Deposit and Performance Bank guarantee of the agency shall be liable to be forfeited in case of failure to execute/complete the job as per contract agreement/contractual terms & conditions within contract liability period or within such extended period approved by the management.

9. ARBITRATION:

Any dispute or difference under or arising out of or in respect of the agreement/work order shall be referred to the Managing Director of the BSLC Ltd., Plot No.2132/5131/5161(Part), Jayadev Nagar, Nageswar Tangi, Bhubaneswar - 751002 or his authorized representative as sole arbitrator and the decision of the sole arbitrator on the matter in dispute shall be final and binding on the contractor and the company. In the event of failure to settle the dispute through arbitration, either party can refer the dispute to the court of Law. In that case the jurisdiction of court shall be 'Bhubaneswar' only.

10. MODIFICATION OF CONTRACT:

No modification and alteration of the contract / agreement will be allowed during the currency of the contract. However difficulties, if any, experienced while implementing / execution of the contract, the same can be addressed with the approval of the MD, BSLC.
