1. The EMD of Rs 5000/- ( Rupees five thousand only) in shape of crossed Demand Draft drawn in favour of “ The Bisra Stone Limestone Company limited” payable at Birmitrapur/Rourkela to be enclosed.
2. The dumper should be available for 12 hours i.e. from 8 AM to 8 PM in good condition for a period of 90 days.
3. The dumper should work as per the instruction of the Mines Manager / Quarry In-charge time to time.
4. The tipper should not be older than 2007 model & driver/operators must possess valid driving license and dumper must have valid Registration certificate, road tax, insurance & fitness certificate.
5. The agency should produce the detail documents of the dumper before commencement of the work. If it comes to the notice of the employer that the agency are found to be submit any false/ fake / doctored documents, then the contract will be cancelled with immediate effect.
6. The participating agency should not have any litigation with BSLC.
7. HSD will be supplied by BSLC @ 01 Ltr. for every 2.5 Km of running.
8. Deployment of driver, helper, supply of lubricants and maintenance of tipper will be on account of the agency.
9. The contract period will be (3) three months from the date of issuance of Work Order.
10. BSLC reserves the right to close the contract at any time without assigning any reason. No compensation shall be payable on this account.
11. The agency will be responsible for compliance of all statutory provisions, maintenance statutory records and payment of statutory dues in time. If any penalty claims by statutory authority due to
