**TENDER NOTICE**

1. Tenders in sealed covers in prescribed form and in conformity with the tender documents are invited from manufacturers/consignment agents/dealers for Supply of Explosives & accessories for blasting operation in BSL Mines at Birmitrapur.

**2. Availability of Tender:** Non transferable tender documents can be obtained from the office of the Manager (Fin),B.S.L.CO.LTD; Birmitrapur during office hours on any working day from Dt.**13/07/2021 to Dt.03/08/2021. (up to 3.00P.M)**.The tender document can also be down loaded from our website [www.birdgroup.co.in](http://www.birdgroup.co.in). In case of downloaded tender, the bidder has to submit an undertaking on the company's letterhead that no amendment have been made in the tender document downloaded from company's website, at the time of submission of the tender document.

**3. Submission of Tender:** The Tender document shall be submitted in two parts i.e. Part-I Techno Commercial Bid and Part-II Price Bid in separate sealed envelopes. Both Techno commercial bid and price bid shall be sealed in separate envelopes with complete tender details superscribed on both the envelopes and clearly identifying the techno-commercial bid and price-bid on the respective envelops. Both the bid shall be kept in another sealed envelope superscripting the Tender Enquiry No. and date and dropped in the Tender Box kept in Conference Hall at General Office of **BSLC, Birmitrapur up to 3.30 P.M on Dt.03/08/2021.**

**4. Techno-commercial bid:** The Part-I, Techno Commercial Bid shall be opened in the presence of the bidders or their authorized representative **at 4:00 P.M on Dt.03/08/2021** in the Office of the Business Head, The Bisra Stone Lime Company Ltd., Birmitrapur,Sundargarh (Odisha).

**5. Price bid:** Part –II i.e. Price Bid of the tenderers, whose Techno Commercial bid are found acceptable , shall be opened on a fixed date & time, which will be intimated to the bidders separately after opening and finalisation of technical bids. In this respect, the decision of the company shall be final and binding on the tenderers. Note: - (Bids received after 3.30 P.M. but before opening at 4.00 P.M. can be accepted & opened, but bids received after 4.00 P.M. will be rejected.)

**6. Pre-bid consultation:**

The tenderers are free to join pre bid consultation to be held on Dt.**26/07/2021 at 3.00P.M.**in the office of the Business Head for clarifying doubt/seeking explanations in regard to provision of the tender. The tender document may be amended suitably if any genuine doubts or explanation sought are needed solely at the discretion of BSLC.

**7.** The company shall not be liable for any delay in submission of the tender documents due to postal delay and no extension of date for tender submission / tender opening shall be given for this reason.

**8.** The company reserves the right not to accept the lowest offer. The company also reserves the right to cancel the tender and in such an event no claim of any tenderer for such a decision by the company shall be entertained. The company may split the contract into two parts in the ratio of 60 : 40 at L1 rate to L1 & any other bidder matching the L-1 rate in the order of ranking.

**9.** The validity of the offer shall be for a period of 180 days.

**10.** Interested Parties are advised to visit the site with AGM (Mines) and familiarize themselves with the site conditions, concerned areas and go through the attached terms & condition of the tender document before submission of tender documents.

**11.** Bidders are required to give an undertaking that they will abide by all the terms & conditions of the tender document as per format given in Annexure - III.

**CHAPTER-II**

**1. SCOPE OF WORK**

Supply of explosives and accessories for BSLC Mines, Birmiltrapur for the Year 2021-22 to 2023-24 (3 years, i.e. from the date of issue of purchase order) as per the technical description given below:

**a) Technical Description of Explosives.**

N.B: As per production planning the above quantity may be increased /decreased.

**b) EXECUTION OF SUPPLY:**

The above supplies have to be made as per delivery schedule or as and when required to be intimated separately or as per receiving date mentioned in the indent (Form RE-11). The agency is required to supply Explosives within 24 hours(01 day) and Detonator / Nonel within 96 hours( 04 days) of intimation by mail/ messages, so that the material will reach at BSLC site within the given schedule time.

**c) LOT DESPATCH/INDENT QUANTITY:-**

Our Indent quantity shall be within the following ranges and accordingly dispatch should be made by you.

- i) Explosive: 2.7 MT (one lot/day)
- ii) Electric Detonator: 1,500 Nos to 4,500 Nos

iii Nonel –7,000 to 20,000Nos

d) **FREQUENCY OF SUPPLY:** Your Vehicle/ Explosive Van should be available at your end for supplying 10 to 25 lots for Explosives and 1 lot for Detonators & Nonel in a calendar month.

e) The Explosives & Detonators/Nonel shall be supplied with a minimum balance self-life of six (6) months & twelve (12) months respectively as per the date printed on the packaging of the manufacturer.

## **2. CONTRACT PERIOD:**

a) The period of contract / supply will be 03 years from the date of issue of Purchase order.

b) The period of supplies may be extended for further period of 01 year at the same price, terms & conditions after successful completion of contract period at the option of BSLC.

## **3. ELIGIBILITY CRITERIA:**

In order to qualify in the techno commercial bid of the tender, the tenderer must produce the following documentary evidence with the techno-commercial bid.

3.1) The agency must have the valid PESO registration certificate/ license.

3.2) The agency has to produce experience certificate in support of supplies for a minimum value of rupees 1.00 Crore (One Crore) in any 12 months period in the last 5 years.

3.3) Valid Dealership Certificate must be produced in case of Dealer.

3.4) Start-up MSEs enterprises are given relaxation in Turnover and Prior experience.

3.5) The average financial annual turnover should be Rs 1.50 Crore during last 3 years ending 31.03.2021. Copy of Balance Sheet & P/L Account, Income Tax return to be enclosed in support of annual turnover.

3.6) GST clearance certificate must be produced.

3.7) GST No. must be indicated.

3.8) Copy of the PAN card and income tax return for last three years(2018-19 to 2020-2021) signed by Chartered accountant is to be enclosed.

3.9) An undertaking, in company /firm's letter head is required stating that the party has not been debarred/blacklisted by any PSU and BSLC at any point of time.

3.10) A declaration to be submitted that the bidder has carefully read all terms and conditions of the tender document and he is fully satisfied and accepted all terms and conditions of the tender as per undertaking format attached as per Annexure – I.

(Note: Submission of any forged documents will attract legal action including rejection of tender or cancellation of contract at the risk and cost of the supplier, if awarded.)

## **4. GUARANTEE:**

Guarantee in regards to trouble free use of supplied Explosives (Class II and Division 0 ) for a period of 06 months & Detonators (Class VI and Division III ) for a period of 12 months from the date of Supply. Free replacement will be carried out by the tenderer for premature failure of items during the guarantee period.

## **5. TAX DEDUCTED AT SOURCE:**

TDS as applicable shall be deducted at the prescribed rate from the gross value of bill. .

## **6. PRICE BID:-**

Bidders are requested to quote their price for supply of explosive at BSLC mines Office in the given price bid format at Annexure-II.

## 7. EVALUATION OF THE TENDERS:

(i) The Part-1 Techno commercial bid: Parties who will fulfil all requisite conditions of eligibility clause of chapter-II of this document will be considered as technically qualified and may be considered for opening of Part-II Price Bid.

ii) **INDIVIDUAL PRICE OFFER:** For Sl. No. 1 of Technical Description (1.a), the agency will be selected on **Individual price** offer basis inclusive of all charges excluding GST.

ii) **COMPOSITE PRICE OFFER:** For Sl. No. 2 & 3 of Technical Description (1.a), the agency will be selected on **Composite price** offer basis inclusive of all charges excluding GST.

## 8. AWARD OF CONTRACT:

8.1) The Company reserves the right to accept or reject any or all tenders or distributes the work/supply amongst different tenderers without assigning any reason thereof.

8.2) Award of contract/purchase order shall be made at the absolute discretion of BSLC. The company reserves the right to reject any part or whole of the tender without assigning any reasons whatsoever. For such cancellation the tenderer shall not be entitled to claim any cost, damages, charges, expenses incidental there-to or incurred by him through or in connection with the preparation and submission without assigning any reason whatsoever.

8.3) BSLC shall not be liable for any delay in receipt of the tender document by the Tenderers due to postal delay and no extension of time to the date of tender opening shall be given for this reason.

8.4) For material indicated in Sl. No. 1 of Technical Description (1.a), the agency will be selected on **Individual price offer** basis inclusive of all charges excluding GST. For Sl. No. 2 & 3 of Technical Description (1.a) the agency will be selected on **Composite price** offer basis inclusive of all charges excluding GST.

However BSLC can split & award the work to more than one agency in the ratio of 60:40 subject to the second or subsequent lowest bidders( L2,L3,L4 in the order of ranking)matching the L1 price. Option to match L1 price will be solicited from second & subsequent lowest bidders in order of ranking. BSLC also reserves the right not to accept the lowest offer.

## 9. SUBMISSION OF BILL & PAYMENT:-

a) The tenderer shall raise the bills in triplicate quoting the Purchase Order no. and date therein for the supplies made by him.

b) The bill shall be submitted to the Stores Department along with valid Challan. This will be forwarded to the Mining department for certification by AGM (Mines). After certification the bill will be forwarded to the Finance department for payment.

c) Payment shall be made within 30 days of receipt of Material, Tax Invoice & submission of Inspection Report by the Indentor & Site-Incharge Jointly after deduction as per statute/tender conditions.

d) Payment shall be made through RTGS/NEFT/CBS/e-payment basis only.

## 10. ESCALATION

Price shall be quoted as per given price variation clauses for Booster cartridge only.

ANo = RCF Original basic Ex- works, Mumbai, price of AN (100% melt), explosive grade as on date of base date to be obtained from RCF. (M/s Rastriya Chemicals & Fertilizers Ltd.) A Govt. of India Undertaking))

HSDr = Revised price of HSD of IOCL (M/S Indian oil corporation Limited), Retail outlet price at Rourkela as on date of price revision.

HSDo = Original price of HSD of IOCL , Retail outlet price at Rourkela as on base date.

- i) = Base price shall be the PO(Purchase Order) price finalised against tender / RFx and the base date shall be the PO date.
- ii) = PO price shall remain firm for first quarter.
- iii) = All other indices shall be measured from the base date.
- iv) = The price shall be done on quarterly basis.
- v) = The revised price/revised indices of each quarter shall be the base price / revised indices for next quarter.

**Note: Price variation indices shall be computed taking into previous revision.( i.e. Revision that took place immediate prior to date of Revision of Price) of HSD price at Rourkela / Birmitrapur whichever is beneficial to BSLC.**

## **11. PENALTY**

Penalty @ Rs 2000/- for each day of delay beyond receiving date as mentioned in Scope of work point no 1(b) shall be imposed and recovered from your bills up to a maximum amount of 5% of the value of the lot indented. If the blasting is failed due to poor quality of explosives material used, then **3 times of cost of explosive** material used for the same blasting purpose shall be deducted as penalty from your bill.

## CHAPTER-III

### **GENERAL CONDITIONS**

#### **1. DEFINITIONS:**

1.1) **Tenderer/Bidder:** Tenderer/Bidder means a person, Society, Firm, or Company willing to participate by accepting terms and conditions given in the tender documents.

1.2) **Tender:** Tender means the work to be perform according to the tender documents (both technical and commercial) submitted by the tenderer for consideration of BSLC.

1.3) **Name of the Tender:** Name of the Tender means the work to be performed by the tenderer.

1.4) **Techno-commercial Bid:** Techno-commercial Bid means documents regarding eligibility condition as stipulated in the tender documents for qualifying the bidder for consideration of the Price Bid.

1.5) **Scheduled Rate:** Scheduled Rate means the rate (inclusive all taxes & duties) quoted by the tenderer in the prescribed format for various activities to be performed by the bidder/contractor.

1.6) **Price Bid:** Price Bid means the document containing the scheduled rate to be considered for the purpose of evaluation and award of contract.

1.7) **Contractor:** Contractor means the person or society, firm, company whose tender has been accepted by the BSLC.

1.8) **BSLC:** BSLC means "The Bisra Stone Lime Company Ltd." A company incorporated in India and having its registered office at REGD. OFFICE: PLOT NO 2132/5131/516(PART), JAYDEV NAGAR, NAGESWAR TANGI, BHUBANESWAR-751002.

1.9) **Employer:** Employer means BSLC

1.10) **Competent Authority:** - Competent Authority means MD or any designated officer by the MD.

1.11) **Taxes:** Taxes means Income Tax, Surcharge, GST, and any Other Tax, Levy, Fees, Cess imposed by the Government from time to time.

1.12) **Lowest Offer:** The price in total found to be lowest shall be the lowest offer (L1).

1.13) **Rate Contract:** Rate Contract means to carry out the whole job of supplies as per scope of work in agreed cost within the specified period.

#### **1.14. Acknowledgement of purchase order and execution of supply:**

The successful bidder is expected to appear in the office of Business Head to acknowledge the receipt of purchase order or receipt through e-mail within 3 days of issuance and start the supplies within 15 days from the date of issuance of purchase order.

#### **2. RESPONSIBILITIES OF THE AGENCY:**

2.1) The supply order is to be accepted by the tenderer within 3 days of communication of the same.

2.2) The tenderer will execute the supplies as stipulated in the tender document.



2.3) The agency shall have to make his own arrangements for travelling, boarding, lodging etc to the site.

2.4) The job cannot be sub-contracted in part or in whole without the written consent of the Business Head of BSLC, Birmiritrapur.

2.5) The tenderer will comply the direction of Business Head or his authorized representative from time to time.

**3. PACKING AND FORWARDING:**

All care should be taken for proper packing and supply of material in good condition to our company's Works/Magazine and the cost so incurred will be borne by the tenderer.

**4. TRANSIT INSURANCE:**

To be arranged by the tenderer at his own cost.

**5. ESCALATION:** Escalation in line with Chapter-II, Point No.10 will be followed.

**6. EXIT CLAUSE:**

The order can be cancelled by either party by giving 30 days notice in writing.

**7. INSPECTIONS :**

Inspection will be offered at our works/site before acceptance/ services rendered by the site in charge.

**8. REJECTION:**

Non standard materials supplies which do not meet our specification/standard/make approved by PESO (Petroleum & Explosives Safety Organisation) found during inspection is liable for rejection which shall be returned back to you for correct replacement within 7 days or earlier at our discretion & the cost involvement will be charged to supplier's account. For rejection material no payment will be made.

**9. TERMINATION OF THE CONTRACT:**

In case of failure to fulfil the contractual terms or if there be any violation of any contractual/statutory provisions, contract may be terminated by giving 30 days notice in writing invoking Risk & Cost Purchase clause as per the tender.

**10. RISK PURCHASE:**

In the event of failure to fulfil the contractual terms for execution of work/supply order as per letter of intent/contract, the company reserves the right to make the contractual obligations carried out by alternative arrangement and the company shall recover from you any additional cost involved therein.

**11. SPECIAL CONDITIONS:**

The Tenderer shall get fully informed/appraised himself of all local conditions and factors which may have any effect on execution of supplies covered under the tender document and specification, BSLC shall not entertain any request for clarification from the tenderer regarding such local conditions after award of the contract. It must be understood and agreed that such factors have been properly investigated and considered while submitting the tender. No claim for financial adjustment to the contract or may be entertained by BSLC on this account. Neither any change in the time schedule of the contract nor any financial adjustment shall be permitted by BSLC which are based on the lack of clear information. An undertaking in this regard in writing must be submitted by the respective bidders.

**12. OTHER CONDITIONS:**

12.1. For any additional supplies not mentioned in this tender shall be carried out by the same tenderer in the same contract on mutually agreed terms and conditions to be made in writing, if required.

12.2. It shall be the responsibility of the tenderer to keep confidential all technical information relating directly or indirectly to the work either disclosed to the tenderer by & /or on behalf of BSLC or acquired by the tenderer during the course of performance of the contract. The tenderer shall not disclose such information to anybody/party without the prior written permission of BSLC. Any contravention of the provisions of this clause will tantamount to breach of the contract.

12.3. With regard to the execution of the order the agency will abide by the direction of the A.G.M (Mines) or his authorised representative of BSLC.

12.4. The Agency will be responsible for payment of compensation to its employees or others caused due to any accident/ incident/litigation by its employees/equipments/vehicles and the same shall be reported to A.G.M(Mines) / In-charge Personnel Dept. immediately. Compensation owing to an accident/litigation occasioned during or in connection with the above work shall be to the account of the tenderer and the company reserves the right to recover the same by way of deduction from the bills in case BSLC is made to pay such compensation if any.

12.5. The Management reserves the right to make addition and alteration in the terms and conditions as stated herein at the time of signing the agreement, if necessary.

12.6. No part of the work shall be subcontracted without the written approval of the undersigned.

12.7. The instructions will be the integral part of the tender document.

### **13. ARBITRATION:**

If any dispute is not settled amicably between the Supplier and Business Head of BSLC, then, all such disputes and differences whatsoever arising between the parties out of or relating to the Contract, meaning and operation or effect of this Contract or the breach thereof shall be settled by Arbitration. Each party shall appoint its arbitrator; the two arbitrators so appointed shall appoint the third arbitrator who shall be the presiding Arbitrator. The arbitration shall be governed by the provisions of Arbitration and Conciliation Act 1996 and the statutory modifications to the said Act. The award made in pursuance thereof shall be binding on the parties.

The further progress of any supply under the Contract/PO shall unless otherwise directed by the Engineer /A.G.M(Mines) / Business Head continue during the Arbitration proceedings and no payment due or payable by the Employer shall be withheld on account of such proceedings. It shall not be open to Arbitrators to consider and decide whether or not such supply shall continue during the Arbitration proceedings.

Provided further that no reference to Arbitration whether the Final Bill for the supply has been passed or not shall be made later than 6 months from the date of satisfactory completion of supplies under the Contract/PO.

No Interest shall be awarded by the Arbitrator in any arbitration proceedings.

The Arbitrator's fee, expenses and all other costs and other expenses relating to the holding of arbitration shall be borne by both the parties equally. However, the fees and expenses of the advocates and expenses relating to the presentation of witnesses shall be borne by the respective parties. Should the arbitrator give specific award in respect of costs then it would prevail.

The Arbitration bench shall make a reasoned award.

The venue of Arbitration shall be at BSLC Office, Bhubaneswar, Odisha.

In case the Supplier is Government of India Undertaking or any Government Department, dispute between the Supplier and the Employer in respect of this Contract/PO shall be settled in accordance with the procedure laid down from time to time by Department of Public Enterprises (DPE)/Government of India.

**14. MODIFICATION OF CONTRACT:**

No modification and alteration of the contract/agreement is allowed during the tenure of the contract. However difficulties, if any, experienced while implementing / execution of the contract, the same can be addressed with the approval of the MD, BSLC.

**15. FORCE MAJEURE CLAUSE:**

Time being the essence of the contract if either party is prevented from the performance of its obligations in whole or in part for reasons of force majeure viz acts of God, acts of Government, acts of public enemy, war, hostility, civil commotion, sabotages, fire, floods, explosions, epidemics, lawful strikes, lockouts or statutory action or any cause of whatever nature or description beyond the control then provide notice of happenings of any such eventuality is given by the affected party to the other party within 15 days from the date of occurrence and cessation of the force majeure the period of force majeure shall be excluded from the time specified for fulfilment of obligations of the party prevented by force majeure. If any of the events specified in this clause lasts for a continuous period of less than 7 days, such events shall not be construed to be force majeure events. Neither party can claim any compensation from the other party because of force majeure events.

**16. COUNTER OFFER:**

Any offer of the contractor which deviates from the terms & conditions stipulated in Chapter-II(Terms and conditions) and Chapter-III(General conditions) of the tender will be treated as counter offer and will be summarily rejected.
