### 3. **PRE BID CONSULTATION:**

The bidders are free to join pre bid consultation to be held on 23.07.2019 at 3.00 PM in the office of the Business Head, BSLC Ltd., *At/Po- Birmitrapur, Dist- Sundargarh, Odisha, PIN-770033* for clarifying doubts/seeking explanations in regard to provision of the tender. The tender document may be amended suitably if any genuine doubts or explanation sought, are needed solely at the discretion of the company. Amendments so made will be published on the company’s website within 5 days before the opening of the bid.

### 4. **TENDER SUBMISSION :**

**4.1.** The Bidder shall submit the tender in 2(two) parts consisting of Part-I: (Techno Commercial) and Part – II: (Price Bid) each in separate envelop duly sealed and Superscribed with the Tender Notice Number.

The instruments of Earnest Money Deposit & cost of tender document are to be put in a separate envelope duly sealed and superscribed with the word Earnest Money deposit & cost of tender document.

All the 03(three) envelope containing PART-I, PART-II , Earnest Money & Cost of Tender document shall be put in a 4<sup>th</sup> (fourth) envelope duly sealed, superscribed with tender notice no, name of the job and addressed to the Business Head, M/s B.S.L.Co.Limited, Birmitrapur.

Tender can be submitted either by post, courier service or deposited in the tender box in the office of the Business Head, M/s B.S.L.Co.Limited Birmitrapur. However, BSLC shall not be responsible for the delay occurring in postal/Courier services resulting in the non-

submission of tender document within time. Tender not received in prescribed format will be liable to be summarily rejected.

**4.2.** Tender will be received up to 3.00PM on 01/08/2019 and will be opened on the same day at 3.30PM in presence of bidder or their authorized representatives.

**4.3.** Tender form containing 'over written' or 'erased' rate or rates and amount not shown in figures and words in English will be liable to rejection.

**4.4.** Any tender containing clerical or arithmetical mistakes may be rejected.

**4.5.** Any request from the bidder in respect of additions, alterations, modifications etc of either terms or conditions or rates of his tender after opening of the tender may lead to rejection of his tender.

**4.6.** The Agency who has been debarred by the BSLC will not be eligible to participate in the tender.

**5. OPENING OF TENDER:**

The Technical bid part-I shall be opened at 3.30 PM on 01.08.2019 in General Office, BSLC, Birmiritrapur, Dist. Sundargarh, Odisha.

Part – II i.e. Price Bid of the Bidders, whose Techno-Commercial Bids are found acceptable shall be opened in the presence of the bidders or their accredited representative afterwards on a suitable date and time in General Office of BSLC, Birmiritrapur, Distt: Sundargarh, Odisha, which will be intimated to the bidders in due course.

**6. VALIDITY:**

The Tender and the prices quoted shall be deemed to remain valid for a period of 120 days from the date of opening of Part-I i.e. Technical Bid. In case of Tenderer revoking or withdrawing/ cancelling his Tender or varying any term in regard thereof during the validity period of the Tender, without the written consent of BSLC, the Tender submitted shall be liable for rejection and the BSLC shall forfeit the Earnest Money paid by the Tenderer along with the Tender.

**7. COUNTER OFFER:**

Any offer of the bidder which stipulates deviations from the terms & conditions stipulated in Chapter-II & Chapter-III of the tender document will be treated as counter offer and **shall** be liable for rejection.

**8. ELIGIBILITY CONDITION:**

**8.1.**

**a).** The agency must have a person of suitable qualifications & experience as per Rule 15 of MCR, 2016 (other than Atomic and Hydrocarbon minerals), who will prepare the Mining Plan/ Review of Mining Plan. Copy of valid RQP certificate issued by IBM.

**b).** The agency must have last 05 (five) years experience in Mining Plan/Scheme of Mining of successful completion of at least 03 (three) projects to their credit and must produce document in support of their credential. Copy of approval order from IBM and completion

certificate issued by the organization in which he worked to be enclosed as details given below:

- i) The Agency must have similar work experience ( Like preparation of mining plan, scheme of mining, preparation of PMCP & FMCP and get it approved from IBM) of Rs 5.17 lakhs per annum . The single similar work should have been executed / completed during the past seven years ending 31.03.2019 and must produce document ( like copy of work order , work completion certificate and approval copy of IBM) in support of their credential.
- c) Cost of Tender Document of Rs. 1,050/-
- d) Earnest Money Deposit of Rs 17,500/- (Rupees Seventeen Thousand Five Hundred only)
- e) Income Tax Return of last 03 years duly certified by a Chartered Accountant.
- f) The Agency should submit IT PAN.
- g) The Tenderer shall be financially sound and should have achieved an average financial annual turnover of minimum Rs 3.10 LAKHS in the last 03 years starting from 2016-17 to 2018-19. The Tenderer shall submit following documents in respect of turnover.
  - i) Turnover duly certified and stamped by his authorized signatory
  - ii) Copies of audited profit and loss accounts accompanied by relevant schedules for last 03 years.
  - iii) Copies of Income tax Return for last three years.

**8.2.** In respect of the above eligibility criteria the tenderer are required to furnish the following required information and documents with their Bids (copies of all documentary evidences are to be duly authenticated by the tenderer/constituted attorney of the tenderer with full signature and seal. All signed declarations are to be made in the tenderer's Letter head.)

- a). Agreement /Work Order of each work along with work completion certificate have to be considered for eligibility.
- b). All signed declarations are to be made in the Tenderer Letter Head.
- c). Registered Partnership Deed in case of a Partnership Firm or Memorandum of Association and Article of Association in case of a Limited Company, or Proprietorship Certificate duly certified by a Notary Public on a Stamp Paper of requisite value in case of proprietorship firm is to be enclosed.
- d). The agency must have GST Registration Number.
- e). The tenderer before submission must sign each page of the Tender Documents. Otherwise the tender will be treated as invalid.
- f). A declaration is to be submitted that the Tenderer has carefully read all terms and conditions of the tender document and he / she is fully satisfied and accepted all terms and condition of the tender as per undertaking format attached as per (Annexure – III). Non submission of Annexure -III in the given format will lead to disqualification.

**N.B.-**

A). Even though the tenderer meets the above qualifying criteria, they are subject to be disqualified if they have made misleading or false representations in the forms, statements and attachments submitted in proof of the qualification requirements, even at a later stage and the contract will be null & void.

B). An undertaking, in Company /firm's Letter head is required stating that, the party has not been debarred/blacklisted by BSLC or any other State or Central PSUs at any point.

## **9. EARNEST MONEY DEPOSIT:**

**9.1.** Tender must be accompanied by an EMD in form of RTGS Receipt / PO / Bank Draft/ Bankers Cheque of **Rs 17,500/- (Rupees Seventeen Thousand Five Hundred only)** in favor of The Bisra Stone Lime Company Ltd. payable at Birmitrapur A/c No.31255294964 of SBI and IFSC Code SBIN0004860 of State Bank of India, Birmitrapur failing which the Tender shall not be considered.

**9.2.** The EMD amount shall not bear any interest. In case successful bidder denies accepting the work order / contract or fails to commence work within 10 days of awarding LOI, their EMD shall be forfeited.

**9.3.** Tender/ bid without EMD shall summarily be rejected.

**9.4.** Earnest Money Deposit of the unsuccessful bidder will be refunded / returned within 1(one) month after finalization of the tender.

**9.5.** EMD of successful bidders will be converted into Security Deposit.

**9.6** Earnest Money should be deposited in form of BG/DD/PO drawn on any Nationalised / Scheduled Bank. The Small Scale Industries who are registered with Industries Department, Government of Odisha or the National Small Industries Corporation Ltd. (NSIC) and MSEs are exempted from submission of Earnest Money Deposit and Security Deposit and shall submit a self-attested copy of the permanent registration of their Small Scale Industries along with their Tender. The SSI/MSEs and NSIC shall submit “Performance Guarantee Bond” (Annexure- V) in lieu of security deposit. The Small Scale Industries who are registered for the particular trade/Item, for which this Tender is relevant, will be exempted from submission of Earnest Money Deposit and Security Deposit. Such industries with their provisional/ temporary registration and not registered for the particular trade/Item for which tender is being invited would not be eligible for exemption.

## **10. EVALUATION OF THE BIDS:**

(i) **The Part-I Techno commercial bid:** Parties who will fulfill all requisite conditions of eligibility clause 8 of Chapter – I of this document, will be construed as technically qualified and may be considered for Part-II Price Bid.

(ii) The Price Bid of Technically qualified bidders shall be evaluated in the light of rate quoted by the bidder and the tender will be evaluated/awarded on the basis of L<sub>1</sub> rate in totality, quoted against the job.

## **11. AWARD OF CONTRACT:**

i) The company reserves the right to accept or reject any or all tenders or distributes/split the work amongst different tenderers without assigning any reason thereof.

ii) Award of contract shall be made at the absolute discretion of BSLC. The Company reserves the right to reject any part or whole of the tender without assigning any reason whatsoever. For such cancellation the tenderer shall not be entitled to claim any cost, charges, expenses incidental to or incurred by him through or in connection with the preparation and submission of tender.

iii) BSLC also reserves the right not to award tender to L-1 and may cancel the whole tender process without assigning any reason or without any liability to any one, whatsoever. In such eventuality Bidders will have no claim against the BSLC what so ever.

## **12. PERFORMANCE GUARANTEE (PG):**

**12.1** On acceptance of the Tender, the Successful Tenderer shall furnish a Performance Guarantee in the form of DD/Banker's cheque/Bank guarantee for an amount of Rs.77,625/-(Rupees seventy seven thousand six hundred twenty five only), before signing of the agreement. If it is submitted in the form of a Bank Guarantee, the same shall be from any of the Nationalized Banks or Scheduled Banks in India and should be valid up to the period of 18 months ( i.e. contract period 06 months, 06 months for DLP and 06 months for claim period) after completion of job.

**12.2** The Bank Guarantee for Performance Guarantee shall be for the due and faithful performance of the Contract and shall remain binding, notwithstanding such variations, alterations or extensions of time as may be made, given, conceded or agreed to between the Agency and the BSLC.

**12.3** The Bank Guarantee for Performance Guarantee shall remain in full force and effect during the period of the Contract and shall continue to be valid up-to warrantee period or expiry of terms of agreement. The Bank Guarantee shall provide for extension of validity on demand by BSLC. Such extension of validity shall be confirmed by the Guarantor Bank without any reference to the Agency. On performance and completion of the Contract in all respects, the Bank Guarantee shall be returned to the Agency on production of certificate from concerned HOD, and other related Department certifying that "the agency is having no dues including all statutory payments".

**12.4** The Bank Guarantee and any amendment thereto shall be executed on a Non-judicial stamp paper of requisite money value as prescribed by the relevant statute in force.

## **12.5 Instructions Regarding Bank Guarantee:**

**12.5.1** All Bank Guarantees for Performance Guarantee and extensions of Bank Guarantees shall be sent in a sealed envelope directly by the Bank through Registered Post to the Business Head of BSLC, Birmitrapur.

**12.5.2** Bank Guarantees / Extensions of Bank Guarantees submitted by the Agency directly will not be admitted.

**12.5.3** The Non-judicial stamp paper for the Bank Guarantee should be purchased in the name of executing bank only.

**12.5.4** The performance guarantee format is given in annexure V.

## **13. SECURITY DEPOSIT (SD) :**

- (i) EMD of successful bidders will be converted into Security Deposit.



- (ii) 5% of the gross bill value (running / final) of the contractor shall be deducted towards Security Deposit including EMD till its reach 5% of contract value.
- (iii) The security deposit does not bear any interest.
- (iv) The Security Deposit shall be released/ settled after expiry of 12 months (defect liability period and claim period) from completion of the job in all respect only after submitting clearance certificate from mining department of BSLC.

14. **OTHER CONDITIONS:**

14.1. The tender document shall have to be signed by the bidder in each page and the terms & conditions must not be altered; failing which, the tender will be rejected

14.2. Tender document containing 'over written' or 'erased' rate or rates and amount not shown in figures and words in English will be liable to rejection.

14.3. Any tender containing clerical or arithmetical mistakes may be rejected. Any request from the bidder in respect of additions, alterations, modifications etc of either terms or conditions or rates of his tender after opening of the tender may lead to rejection of his tender.

14.4. Accommodation during the field survey will be provided by BSLC.

14.5 Equipments, Transporting vehicles and all other incidental expenditure will be borne by the agency.

14.6 BSLC reserves the right not to accept the lowest offer.

14.7 BSLC shall not be liable for any delay in receipt of the tender document by the Tenderers due to postal delay and no extension of time to the date of tender opening shall be given for this reason.

14.8 In case the tenderer declines to take up the work or fails to cope up with the progress of work, BSLC reserves the right to terminate the contract and forfeit the earnest money of the agency and the cost of the work he/she have done by that time and work may be rescinded.

14.9. The Area of land to be surveyed may vary +/- 10% for which no extra payment / deduction will be made by the company.

14.10. The Maps/reports if found to be rectified by the respective authority of statute in any stage will have to be rectified/modified by the agency & resubmitted to the BSLC free of cost.

14.11. The law & order, local administration will be handled by the BSLC.

14.12. BSLC shall not be liable for payment of any compensation in the event of any accident/injury/death caused to any of the workmen so engaged by the agency/ contractor during the tenure of the contract period.

14.13. Any waiver of any clause of this contract can be done only by the competent authority of the Company.

14.14. The workmen to be deployed by the contractor should not be suffering from any chronic ailments. They should have sound physical and mental health and should be free from any physical disability which would interfere in the normal discharge of their duties. The workmen should be free from eyesight and hearing defects.

14.15. Medical treatment to the extent available at the Company hospital will be extended to the workmen engaged by the successful bidder for which consultation, cost of medicines and treatment charges will be paid by the successful bidder.

14.16. The successful bidder and their workmen shall maintain absolute integrity and discipline in performing their duties under the contract. The workmen while performing their duty should be free from the influence of alcohol or any other intoxicant or drugs. Any such instance of violation of the directive shall amount to non-performance of duty involving wage cut or penalty and even termination of such person from duty.

The workmen in their dealings with the employees of the Company must show politeness, loyalty and respect.

In the event of any act of indiscipline on the part of the workman, the Company reserves the right to remove such workman on the advice of the officer in charge of the contract. The successful bidder shall be duty bound and liable to replace such workman.

**1. SCOPE OF WORK:**

The Bisra Stone Lime Company Limited (BSLC), a Government of India Enterprise under Ministry of Steel, is having substantial reserves of Dolomite & Limestone within its leasehold area in Birmitrapur, District – Sundargarh, Odisha. **Description of Scope of work:**

**1. PREPARATION OF MINING PLAN-**

- a) Preparation & Approval of Mining Plan along with progressive mine closure plan of Birmitrapur Limestone & Dolomite mine of M/s Bisra Stone Lime Company Limited, in the district of Sundargarh, Odisha. for an area of 793.043ha. for the production of 2.83 MTA Lime stone and 2.43 MTA Dolomite per annum for the period from April-2020 to March-2025
- b) The mining plan will be prepared as per the guideline of MMDR, 1957, MCDR, 1988, MCR, 1960, MCDR (Amendment), 2017, MCR, 2016 and IBM circular, notification etc.
- c) The Agency will visit the BSLC Mine office of the concerned department for collection of all related data/ information/maps.
- d) The agency/Consultant will visit the ML area/mines and take the data i.e. Location, height of the benches of existing quarries, Location of dumps, existing road alignment etc. and discuss with our technical personnel about proposed MP/MS.
- e) Updating of Surface plan.
- f) Preparation of the existing plans, maps & sections in digitised form in AutoCAD.
- g) Before submission of draft copy in the IBM office the consultant will submit one copy of Mining Plan/Review of Mining Plan along with maps/plans to BSLC for vetting.
- h) Field visit and survey works required towards the preparation of Mining Plan will be done at the cost of the consultant for the Birmitrapur Limestone & Dolomite Mines, Birmitrapur.

- i) The Agency will comply and be responsible for any deficiency pointed out by regulatory authorities for preparing the Mining Plan.
- j) The Agency will provide the chemical analysis and Bulk Density report of Major & Minor Mineral from NABL Accredited Laboratory.
- k) The Agency will provide the Quantity and Quality certificate of waste dumps from NABL Accredited Laboratory.
- l) The Agency will get approved the Mining Plan from IBM, Bhubaneswar/ Nagpur.
- m) The Agency will also be responsible for any adverse remarks by any regulatory authority and will comply the adverse remarks to get positive favorable order.
- n) The Agency will do all the Liaisoning works with the Govt. Authorities.
- o) During the visit to mines site Fooding and Conveyance will be arranged by the Agency.
- p) The Agency shall provide all data in soft copy and hard copy submitted finally to IBM for approval.

**2. AREA OF OPERATION:**

The location of operational **ML of BSLC** is at Birmitrapur Limestone & Dolomite mine (Area – 793.043Ha.) of Birmitrapur in the Dist: Sundargarh, Odisha for which field survey shall be done by the Agency.

**3. WORKING HOURS:**

The working hours at mines lease site shall be round the clock for whole of the calendar month. On Sundays/Holidays, the job shall have to be done by the agency as per the requirements which shall be at the discretion of BSLC. No extra cost shall be paid by BSLC for such work on Sundays/Holidays.

**4. CONTRACT PERIOD:**

The work/project has to be completed within 06 calendar months from date of awarding of the LOI. No extension of time period shall be entertained without sufficient justification to the satisfaction of the management (BSLC).

**5. COMMENCEMENT OF JOB :**

The agency shall commence the work within **10 days** from the date of receiving the Letter of Intent and shall sign agreement as per annexure IV.

**6. RESPONSIBILITY OF BSLC:**

- 6.1. BSLC shall provide free accommodation facility during survey work at the mines.
- 6.2. BSLC shall depute the officials of concerned department like Mining, Geology and Survey for identification of different area during survey work.
- 6.3. BSLC shall provide requisite maps, data and information.
- 6.4. BSLC shall bear all the statutory fees as required, for which the agency will intimate for the same.

**7. SUBMISSION OF BILLS:**

- i) The Agency will submit the running bill after completion of the each volume of work mentioned as per schedule of payment, which will be certified by the Geologist, Surveyor and Mines Manager. The bill duly approved by Business Head will be forwarded to the finance department for release of payment within 30 days.
- (ii) GST, if applicable, shall be paid extra on the bill value at applicable rates. A copy of the GST paid challans must be submitted after deposit of GST, for reimbursement, if any.

**8. PAYMENT TERMS:**

- i) Payment will be made through RTGS/NEFT. The agency will have to submit the details of Bank A/c No., Branch, IFS Code, etc. for receiving the payment through RTGS/NEFT.
- ii) Finance department will arrange the payment within 30 days of receiving of the bill duly approved by Business Head.
- iii) The payment will be subject to deduction of any penalty and statutory liability applicable to the contractor under the contract agreement/work order/statute.

**iv) Schedule of Payment:**

- a) 10% of the job value will be paid on submission of draft Mining Plan at IBM, Bhubaneswar on documentary proof.
- b) 20% of the job value will be paid after compliance of scrutiny points if any of IBM, Bhubaneswar officials visit for Mining Plan.

**9. TAX DEDUCTED AT SOURCES:**

Income Tax and other taxes as applicable shall be deducted at source at the rate prescribed in the Income Tax Act and or other Act from the gross value of each bill.

**10. PENALTY:**

In case the successful bidder fails to take up the work or fails to complete the original job after issuance of LOI/Work Order, BSLC may at its discretion, impose upon any or all of the following penalties-

- (i) If the job is not started within 10 days of awarding of LOI by the tenderer, the work order shall be treated as cancelled and the entire EMD/SD with the company shall be forfeited.
- (ii) Security Deposit may be forfeited wholly or partly without notice to the Agency.
- (iii) Recovery of extra cost incurred by the company for getting the work done through other sources without information.

- (iv) Blacklisting of the Agency.
- (v) Recovery from any of the other present/future pending bills of the Agency.
- (vi) BSLC will have the right to recover the penalty as per terms and conditions of the contract from the bill of the contractor / security deposit besides taking the legal course of action, if required, for recovery of the same.
- (vii) The work has to be completed within 09 calendar months after the award of contract. If the Agency failed to complete the work within the specified time, then penalty will be deducted @ Rs 1000/- per day beyond the scheduled time.

**CHAPTER – III**

**GENERAL CONDITIONS**

**1. DEFINITIONS:**

- a) **Tenderer/Bidder:** Tenderer/Bidder means an Individual, Society, Partnership Firm, Consortium or Company willing to participate by accepting terms and conditions given in the tender documents.
- b) **Tender:** Tender means the work to be perform according to the tender documents (both technical and commercial) submitted by the bidder for consideration of BSLC.
- c) **Name of the Tender:** Name of the Tender means the work to be performed by the bidder/tenderer.
- d) **Techno-Commercial Bid:** Techno-commercial Bid means documents regarding eligibility condition as stipulated in the tender documents for qualifying the bidder for consideration of the Price Bid.
- e) **Scheduled Rate:** Scheduled Rate means the rate quoted by the tenderer in the prescribed format for various activities to be performed by the tenderer.
- f) **Price Bid:** Price Bid means the document containing the scheduled rate to be considered for the purpose of evaluation and award of contract.
- g) **Contractor/Agency:** Contractor means the Individual, person, society, firm or company whose tender has been accepted by the BSLC.
- h) **BSLC:** BSLC means “The Bisra Stone Lime Company Limited”. A company incorporated in India and having its registered office at AG-104, Saurav Abasan, 2<sup>nd</sup> Floor, Sector – II, Salt Lake City, Kolkata – 700091

- j) **Competent Authority:** Competent Authority means Managing Director (MD) or any designated officer by the MD.



k) **Taxes:** Taxes means Income Tax, Surcharge, GST, Cess Tax, Entry Tax, and any Other Tax, Levy, Fees as imposed by the Government from Time to Time.

**2. SIGNING OF AGREEMENT:**

- D. Permanent Account Number allotted by Income Tax Department.

**3. INTEGRITY PACT:**

**4. TERMINATION OF CONTRACT:**

BSLC reserves the right to terminate the contract either in part or in full due to reasons for not fulfilling the contractual obligations as per work order/agreement, unsatisfactory performance, bad working, indulgence in corrupt practices and theft of the company's properties or any other abnormalities noticed during the operation of work. BSLC shall in such event, give immediate Thirty (30) days notice in writing to the agency for the termination of the contract. In such case, contractor will continue to be liable for the notice period and the work done during the contract period.

**5. RISK PURCHASE:**

In the event of failure to fulfill the contractual obligations as per Work order/agreement of contract, the company reserves the right to make the contractual obligations carried out by alternative arrangement at the sole risk and cost of the agency and the company shall recover from the agency any additional cost involved therein. The EMD / Security Deposit of the agency shall be liable to be forfeited in case of failure to execute/complete the job as per contract agreement/contractual terms & conditions within contract liability period or within such extended period approved by the management.

**6. PRICE ESCALATION:**

The price quoted by the agency will remain firm & fixed during the tenure of the contract. No price escalation will be allowed by BSLC at any time for whatsoever the reason.

**7. STATUTORY COMPLIANCE:**

**7.1.** The Agency shall comply and abide by all the provisions, orders etc. framed under F.C. Act 1980, E.P. Act, 1986, MMDR Act, 1957, MCDR, 1988, MCR, 2016, MCDR (Amendment), 2017 & Minimum wages Act & rules/regulations/guide line and all other applicable laws framed there under and amended from time to time by the Central Government, State Govt., MoEF, IBM, DGMS and the Pollution Norms stipulated by OSPCB.

**7.2.** The Agency will have to maintain all statutory forms, records, registers, licences and other documents required as per Mining Laws, Personnel Laws, Provident Fund Rules and other applicable Laws related to and governing such type of works. Payment, safety, training, compensation, bonus of personnel employed for this job shall be according to laws governing such type of works.

**7.3.** The tenderer shall be responsible for compliance of all the provisions under Mines Act 1952. Any violation in this regard will be treated as breach of contract and recovery action shall be taken by the Company as deemed fit in this regard including recovery of penal damages levied by the Government Authority including that of termination of the Contract.

**8. FORCE MAJEURE CLAUSE :**

i) The Contractor shall have no claim whatsoever against the Company for any loss/damage caused to the contractor by reason of war, riot, commotion, disturbance, pestilence/epidemic sickness, strike, lock-out, earthquake, fire, storm, flood, explosion, any change in the nature of deposits, break down at plant or machinery for whatever reason, failure/restriction of electrical or other power. Act of God, scarcity/insufficiency of supply of wagons by Railways, preventing or delaying the loading of ores, Government requisition, Govt. order or statutory action of any Govt. agency or any cause of whatever nature or description beyond the control of the Company.

- ii) Either party affected by the force majeure will provide notice of happenings of any such eventuality to the other party within 7 days from the date of occurrence and failure will not give any benefit.
- iii) The Contractor shall resume the work as soon as practicable after such eventuality has ceased to exist of which the Company shall be sole judge.
- iv) If the performance in whole or part of any term/obligation under the contract is prevented or delayed by any such eventuality for a period exceeding seven days of escalation of above events the contract may be terminated at the discretion of the Company.

**9. DAMAGE TO BSLC PROPERTIES:**

The Agency will be fully responsible for any loss/damage that may be caused to the premises, equipment, machinery, and other installations of BSLC in the course of removing the material brought by the agency. The agency will be fully responsible to reimburse all damages as may be determined by BSLC.

**10. ILLEGAL GRATIFICATION:**

Any bribes, commission, gifts or advantage given, promised or offered by or on behalf of the bidder /customer or his partner, agent, or servant to any officer, servant, representative, or agent of the company in relation to the obtaining or to the execution of this or any other contract with the company for showing or for bearing to show favor or disfavor to any person shall be resulting into the cancellation of this contract.

**11. DEVIATION:**

Any deviations shall not be allowed in the tender document by the tenderer whether they are commercial or technical. Any willful attempt by the bidders to camouflage the deviation, by giving them in the covering letter or in any other documents, then the prescribed schedules may render the bid itself non-responsive. Any incomplete tender or conditional tender received shall be liable for rejection.

**12. MODIFICATION OF CONTRACT:**

The Company reserves the right to make any modification/alteration in the condition as mentioned in the Tender by signing the agreement with the successful bidder(s) to avoid any confusion or for interpretation of any terms and condition of the contract. In general, no modification will be done to the contract other than exceptional situations where permissible.

**13. ASSIGNMENT:**

This Agreement is not assignable and non-transferable.

**14. LAWS GOVERNING THE AGREEMENT:**

**14.1.** The Agreement shall be subject to Indian Laws, Rules and Regulations, notifications etc. issued by the Govt. from time to time.

**14.2.** Chapter I, Chapter II and Chapter III will be integral part of the tender document/agreement.

**15. LEGAL CAPACITY OF THE TENDERER:**

**15.1.** The Tenderer shall satisfy the Employer that he is competent and authorized to submit tender and/or to enter into a legally binding Contract with the Employer. To this effect, any individual signing the tender shall, before so signing, submit documentary evidence that his signature on the tender submitted by him, is legally binding upon himself, his firm or company, as the case may be.

**15.2.** A person signing the tender form or any document forming part of the contract on behalf of another shall be deemed to warrant that he has authority to bind such other and if it is discovered at any time that the person so signing had no authority to do so, the Employer may, without prejudice to other legal remedies, terminate the contract and hold the Tenderer and/or the person signing liable for all costs and damages.

**16. ARBITRATION:**

i) All disputes and differences, whatsoever, arising between the parties out of or relating to the contract, meaning, scope, operation or effect of this contract or breach thereof shall be settled between the Employer and the agency amicably. If however, the Employer and the agency are not able to resolve their disputes and differences amicably as aforesaid, such disputes and differences whatsoever arising between the parties out of or relating to the contract, meaning and operation or effect of this contract or the breach thereof shall be settled by Arbitration by referring the claims to the sole Arbitrator to be appointed by the Managing Director/Chief Executive (designated by any other name) of the Employer/Company, who shall be the appointing authority of sole Arbitrator.

ii) The arbitration shall be governed by the provisions of Arbitration and Conciliation Act 1996 and the statutory modifications to the said Act. The award made in pursuance thereof shall be binding on the parties.

iii) The further progress of any work under the contract shall unless otherwise directed by the Business Head/Mines Manager Continue during the Arbitration proceedings and no payment due or payable by the Employer shall be withheld on account of such proceedings. It shall not be open to Arbitrators to consider and decide whether or not such work shall continue during the Arbitration proceedings. Provided further that no reference to Arbitration whether the final bill for the work has been passed or not shall be made later than 6 months from the date of satisfactory completion of the work under the contract.
