CHAPTER-II

NOTICE INVITING TENDER

INTRODUCTION:

The Bisra Stone Lime Company Limited (BSLC), a Government of India Enterprise, is having scrap Material within its leasehold area in Birmitrapur, district –Sundargarh, Odisha. BSLC intends to sell these products “**AS IS WHERE IS BASIS**” to the interested agencies.

1. SCOPE OF WORK: It includes the following:

- a. The bidder will purchase the scrap material on **AS IS WHERE IS BASIS** from the earmarked area/stack shown by authorized person of Business Head, BSLC for lifting the material from the mines.
- b. The lifting of materials will be done by mechanical means only in presence of BSLC officials during working days and hours.
- c. The materials are to be lifted and transported by road only.
- d. The bidder will make own arrangement for lifting and transporting of materials from specified stock of BSLC mines within the specified time.
- e. The bidder will abide by the rules/procedures/instructions framed/communicated for lifting & transporting of scrap material by Government, Government departments and BSLC.
- f. The lifting of materials of permitted lots/ quantity must be completed within the scheduled time and no extension of time will be allowed in normal circumstances.
- g. The materials are to be purchased on advance payment of material value including taxes & duties only.

2. APPROXIMATE QUANTITY OF SCRAP MATERIAL: Materials as per Material description in clause tender schedule of chapter I of the tender document.

3. TERMS OF CONTRACT FOR SUPPLY OF SCRAP MATERIAL:

Scrap Material shall be offered to the H-1 Bidder from the specified location of BSLC. The cost per lot offered by H1 bidder shall be exclusive of loading cost, transportation cost and all taxes. The taxes and levies such as Cess, GST etc will be payable by the buyer as per applicable rates from time to time. If the H1 bidder is unable to lift the allotted quantity, BSLC shall offer the same to H2, H3 bidders and so on, if they accept to match the H1 price.

Note- The successful bidder has to arrange loading of materials on its own from the designated area.

4. CONTRACT PERIOD:

The period for lifting of Scrap Material shall be for **30 DAYS** initially from the date of issue of release Order/ Delivery Order. If any goods for which release order/delivery order is issued and could not be delivered to the customer within the stipulated time, either in full or in part due to reasons

attributable to BSLC, BSLC may extend the date fixed for removal of the goods for a period as deemed fit. BSLC also reserve the right to sell the surplus available quantity, if any, within the stipulated period or during the extended period to any of the parties who participated in the tender at the H1 rate and other applicable terms and conditions.

Any decision in this regard shall be the sole discretion of BSLC which cannot be challenged.

5. EARNEST MONEY DEPOSIT(EMD):

5.1 Tender must be accompanied with a non-interest bearing earnest money as mentioned against each lot.(Ref:Chapter-I)

NOTE: Non submission of EMD will reject the evaluation of the bid.

5.2 The Earnest Money should be deposited by way of account payee Bank Draft/ Bankers Cheque on any Nationalized Bank in favour of **“The Bisra Stone Lime Stone Company Limited” payable at Birmitrapur.** Earnest Money can also be deposited in cash if the total amount to be deposited towards EMD is equal to or less than Rs.5000/-.

5.3 Cheques, Bonds, Guarantee bonds and Govt. Securities (Stock Certificates, bearer bonds, promissory notes, cash certificates) will not be accepted towards EMD. No interest will be paid on EMD.

5.4 The Central Public Sector Enterprises (CPSEs) under Government of India and NSIC certificate holders are exempted from submission of EMD/Bid Security.

5.5 Details of EMD i.e. draft number and date should be indicated on the cover of the Envelope otherwise, the tender shall stand rejected and will be returned to the tender. Earnest Money shall be refunded to the unsuccessful bidder after one month of the finalization of the tender but without any interest.

5.6 The Pre-Bid EMD of successful bidders (SB) will get automatically converted into Security Deposit. The EMD amount may be refunded after successful completion of contract as mentioned in clause 6 Security Deposit.

6. SECURITY DEPOSIT(SD) :

The Pre-Bid EMD of successful bidders (SB) will get automatically converted into Security Deposit. The SD will be released to the Bidder on the following terms and production of certificate from Mines Manager & the Finance Department certifying that:-

- a) The allocated quantity / lot is successfully lifted by the successful bidder (SB) within the specified time.
- b) No money is payable by the buyer to BSLC.
- c) All statutory dues payable to the State and/or Central Authority have been paid.
- d) All statutory obligations have been complied with.
- e) SD will be released after one month from the date of completion of the contract.

The SD will be forfeited:

- a) Each lot will be treated as an independent contract and will be bound by the terms & conditions specified in the catalogue.
- b) For each individual lot, the successful bidder has to lift minimum quantity against each of the concerned lots as specified in the tender document.

The party has to ensure that all the pollution norms/Forest Rules as applicable in the State during loading and transportation are followed. For any violation of pollution norms/Forest Rules by the party BSLC can't be held responsible on any account in this regard.

7. ELIGIBILITY CRITERIA:

7.1. The Tenderer shall have to submit an EMD for each Lot separately and payment of cost of tender document i.e. Rs. 525/- along with Techno-Commercial cum qualifying bid failing which the bid will be liable to be rejected.

7.2 Must produce GST registration certificate.

7.3 Clearance certificate from State Pollution control Board for hazardous material.

7.4 Income Tax return for the Fin.Year 2015-16 has to be submitted.

7.5 An undertaking in company/ firm's letter head is to be submitted stating that, the party has not been debarred / black listed by BSLC or any other PSUs/ Government agencies at any point of time.

7.6 A declaration to be submitted that the bidder has carefully read all terms and conditions of the tender document and is fully satisfied and accepted all terms and condition of the tender as per undertaking format attached as per Annexure).

(Note: Submission of any forged document will attract legal action including rejection of tender or cancellation of contract at the risk and cost of the contractor if awarded).

7.7 A certificate should be furnished that the bidder has no litigation with BSLC, as parties /company having any litigation with BSLC are not eligible.

8. PRICE BID: Bidders are required to quote rates per lot in a format as specified in the Price Bid. The price bid shall be valid for **30** days. Clubbing of prices offered for more than one lot will be treated as cancelled.

NOTE: Best rate quoted per LOT according to the item (Description of material) is exclusive of GST, and other applicable levies. GST as applicable at the time of supplies will be chargeable extra and payable by the buyers at applicable rate. Any increase/decrease in GST or imposition of any new duties & taxes by Statutory Authorities would be on the account of buyers and payable by the buyers. All sales will be under Odisha GST sales & ET applicable.

9. EVALUATION CRITERIA :

9.1 Tenderers, who qualify the Techno-Commercial cum qualifying bid on fulfilling the criteria fixed in the Eligibility Criteria, will be eligible for opening of their respective price bid.

9.2 The price bids of the qualified parties will be opened in presence of the eligible parties at the Office of Business Head, BSLC, Birmitrapur.

10. AWARD OF CONTRACT/ SALE ORDER:

10.2 Award of contract/ sale order shall be made at the absolute discretion of BSLC.

The company reserves the right to reject any part or whole of the tender without assigning any reason whatsoever. For such cancellation the tenderer shall not be entitled to claim any cost, charges, expenses incidental to or incurred by him through or in connection with the preparation and submission of tender.

10.3 The sale quantity will be made to H-1 bidder on acceptance of its rate to management. Other bidders like H-2, H-3 and so on will be allowed to lift the balance material, if any, on matching the price of H1.

10.4 BSLC also reserves the right not to award tender to H-1 and may cancel the whole tender process without assigning any reason or without any liability to any one, what so ever. In such eventuality Bidders will have no claim against the BSLC what so ever.

10.5 The H-1 bidder will be allowed to lift the quantity asked by him at highest rate first and then next bidder will be allowed to lift the quantity asked by him at H-1 rate and not at his offered rate. If H-2 bidder does not agree to match with highest rate finalised by BSLC, then his offer will not be considered and no claim by him will be entertained. This procedure will be followed till exhaustion of offered quantity or validity period whichever is earlier and under sole discretion of BSLC.

11. TERMS OF PAYMENT

UPON PAYMENT OF FULL MATERIAL VALUE FOR BID AMOUNT, THE ISSUANCE/ DESPATCH ORDER IS TO BE MADE BY BSLC.

The successful bidders shall be required to deposit non-interest bearing advance payment covering full value of 100% of the material within 10 working days from date of issuance of sale approval offer.

All payments towards material value, taxes, levies, etc are to be made in the form of DD/PO in favour of "The Bisra Stone Lime Co. Ltd" drawn on a Scheduled/Nationalized Bank and payable at Birmiritrapur / Any electronic mode of payment approved by RBI and are to be deposited with BSLC, Birmiritrapur. Bank collection charges, if applicable shall be borne by the successful bidders.

12. PENALTY

Failure to deposit payments: Failure to deposit any or all of the above payments within the stipulated period will result in termination of contract without any notice to the successful bidder (SB), forfeiture of Pre bid EMD /SD as the case may be. Non-submission of any payment or failure to lift the material within stipulated time limit may lead to debarring the buyer from participation in BSLC tenders.

13. MODE OF DESPATCH

The delivery of materials in terms of Delivery Order issued shall be taken by the successful bidder (SB) within the stipulated period mentioned in the Delivery Order and also strictly according to any other instructions /delivery programme given by the concerned BSLC Management from time to time.

The Successful Bidders shall make necessary arrangements for lifting and transportation of materials Ex-Stock/plot basis at their own cost. If successful bidder fails to lift the material within the stipulated time of the contract, the EMD and Material value as per clause of abandoned Goods for the concerned lot shall stand forfeited with the closing hour of the contractual period, until the contractual period is extended under clause 4 Contract Period. If the bidder fails to lift the quantity even during the extended period, with the closing hours of the extended period the EMD and Material value as per clause of abandoned Goods for the concerned lot shall stand forfeited.

14. DELIVERY

Tentative schedule – Up to Contract period subject to availability of materials. The materials (committed quantity) have to be lifted through Road Transport at the cost of buyer.

The materials sold shall be removed by the buyer from any one side of the lot as per the sole direction of BSLC and no segregation of items from the sold lots will be permitted.

In case any hot work permission is required for dismantling operations, the same will have to be obtained by the buyers from the BSLC's authorized representative before lifting and it will be sole discretion of the Principal to allow such hot work permission.

"The contract shall be valid for the contract period, both in terms of quantity and price. In case the buyer fails to lift the full quantity within the contract period whatsoever the reasons may be, the shortfall quantity shall be forfeited w.e.f. closing hours of the contract period.

15. TAXES AND DUTIES

The prices determined by the Seller as per Para -8 (PRICE BID) above are exclusive of levies, duties, taxes etc. All levies, cess, duties, taxes including labour welfare cess or any other statutory duties that will be in force on the date of sale or that may be introduced subsequently, will be payable by the Buyer before lifting of materials.

16. LIFTING & TRANSPORTATION:

The buyer shall make necessary arrangement for lifting and transportation of materials on Ex- Stock basis from BSLC store yard/stock yard/allotted location at their own cost within scheduled period.

17. DELIVERY SCHEDULE:

Successful bidders have to lift the total offered quantity within the contract period.

18. INSPECTION: Interested buyers if desire can inspect the material available for sale at BSLC Store yard, Birmitrapur, Dist – Sundargarh (Orissa) in office hours. Once materials are dispatched, BSLC will not be held responsible for the quality of the materials.

19. ABANDONED GOODS:

a. The Successful Bidder must have effected complete removal of the goods from the site within the date specified in the delivery orders issued by the BSLC. In case goods are not removed in full within the specified date, delivery orders for the left over quantity will be treated as cancelled. The goods so left over will be treated as abandoned goods at the risk and cost of the Successful Bidder. BSLC will have full right on such abandoned goods and will be entitled to dispose of the same in any manners it deemed fit without any reference to the Successful Bidder. The Successful Bidder will have no claim on goods treated as abandoned goods. The Successful Bidder shall further be held liable to compensate BSLC for any loss as stipulated in Para (b) below.

b. **RECOVERY AGAINST ABANDONED GOODS:-** In case the successful Bidder does not lift entire quantity the EMD will be forfeited & material value of the concerned lot will be refunded.

22.6 Successful bidders whose bid has been approved by BSLC, should intimate the name & address of their local representative who should be present at the work site and coordinate with the executing Department to carry out the job properly. All-important communication with successful bidder shall be through letters and / or notices put up in Notice Boards at Birmirapur and it will be obligation of successful bidder not to overlook such Notices. Any plea of ignorance of such Notices / letters put up in the Notice Board at Birmirapur shall not be accepted.

22.7 BSLC accepts no liability towards any claim, compensation / damage that may arise out of non-fulfillment of contracts between the successful bidder and any third party. BSLC will give no cognizance to such 3rd party with whom it has no privity of the contract.

22.8 A contract shall be deemed to have been concluded between successful bidder & BSLC upon acceptance of the bid by BSLC in writing and the terms & conditions herein shall be binding on both the parties.

22.9 In the event the successful bidders whose bid has been approved by BSLC, desires that the challans are to be issued stipulating consignee and destination subject to the provision of the relevant Sales Tax Act, the same may be considered provided the successful bidders makes a written request to that effect and indemnify BSLC against non-delivery of materials to the nominated consignee / destination for which the successful bidder/s shall be responsible for all cost and consequences.

22.10 The bidders shall adhere to the Plant Act, Rules, Plant Regulations and Order issued under them.

22.11 It shall be the responsibility of the persons submitting the applications to ensure that the documents have been submitted in the formats and as per the terms and conditions prescribed in the tender document and no change is made therein before submission of their documents in the event of any doubt regarding the terms and conditions /formats, the person concerned may seek clarifications from the authorized officer of BSLC. In case any tampering/unauthorized alteration is noticed in the documents submitted, the said documents shall be summarily rejected and BSLC shall have no liability whatsoever on the matter.

However, deviation if any, proposed by the applicant may be separately indicated be for acceptance or otherwise of BSLC. Such proposed deviation will not be treated as tampering for the purpose of application of this clause.

22.12 Sale of Hazardous Waste Items:

06. ILLEGAL GRATIFICATION

The Company reserves the right to make any modification/alteration in the condition as mentioned in the Tender by signing the agreement with the successful bidder(s) to avoid any confusion or for interpretation of any terms and condition of the contract.

08. ASSIGNMENT

This Agreement is not assignable and non-transferable.

09. FORCE MAJEURE

If at any time during the subsistence of this Agreement either party becomes incapable to perform whole or in part any obligation under this Agreement due to any acts of God, strikes, go-slow, Loading Plant breakdown, Government ruling, Court orders, war, blockade, revolution, civil commotion, riots, floods, plague, or other causes, the Buyer or Seller shall be relieved of all future responsibility for performance of this Agreement.

10. LAWS GOVERNING THE CONTRACT

10.1 The Contract shall be subject to Indian Laws, Rules and Regulations, notifications etc. issued by the Govt. from time to time.

10.2 Chapter I, Chapter II and Chapter III will be integral part of the tender document/agreement.

11. ARBITRATION

11.1 For Buyers other than PSU:-

In the event of any dispute or difference between the buyer & seller, such dispute or difference shall be resolved amicably by mutual consultations. If however, any dispute or difference remains unresolved, the same shall be settled by arbitration by referring the claims to the sole Arbitrator to be appointed by the Managing Director/Chief Executive (designated by any other name) of the seller, who shall be the appointing authority of sole Arbitrator.

The venue of Arbitration shall be at Odisha and the cost of the Arbitration shall be as decided by the Hon'ble Arbitrator. No court shall have the jurisdiction to settle any dispute in view of this arbitration Clause. The

award of such arbitration shall be binding on both the parties. Subject to above, the proceedings shall be as per the arbitration and Conciliation Act 1996.

Notwithstanding above, if any matter need judicial adjudication, the Courts of Odisha only will have jurisdiction.

11.2 For PSU Buyers:-

In the event of any dispute or difference between the parties hitherto, such dispute or difference shall be resolved amicably by mutual consultations. If however, any dispute or difference remains unresolved, the same shall be settled by arbitration. The arbitration procedure shall be as per DPE guidelines, as laid down by the Government from time to time. The venue of Arbitration shall be Odisha and the cost of the Arbitration shall be as decided in the Arbitration award. The courts of Odisha will only have jurisdiction for any unsettled issues needing judicial interpretation.

12. CONFIDENTIALITY:

Absolute secrecy is to be maintained by the buyer in respect of any information or other technical details that the buyer may come to acquire/know during the course of the contract.

13. NON-CIRCUMVENTION AGREEMENTS

The buyer undertakes not to interfere or even attempt to interfere with the running of the business of the seller in any way whatsoever.

14. COUNTER OFFER:

Any offer of the bidder which stipulates deviations from the terms & conditions stipulated in Chapter-II & Chapter-III of the tender document will be treated as counter offer and shall be liable for rejection.
