You are requested to offer your lowest competitive rate for the above captioned subject followed by following terms & conditions.

Terms & Conditions for deployment of JCB Excavator:-

1. Scope of work-

- (i) Engagement of 01 no. of JCB Excavator (Not older than 2008 model) for making berms & fences inside the mines.
- (ii) The Excavator should be available during working hours i.e. from 7 AM to 12 Noon & 2 PM to 5 PM in good condition for 200 hours with a maximum engagement time of 08 hours/day.
- (iii) The Excavator should work as per the instruction of the Mines Manager / Quarry In-charge time to time.
- (iv) The Excavator should not be older than 2008 model & operator must possess valid operating license and Excavator must have valid Registration certificate, permit, insurance & fitness certificate etc.
- (v) The Excavator may be owned or hired by the bidder.
- (vi) The agency should produce the detail documents of the Excavator before commencement of the work. If it comes to the notice of the employer that the agency is found to submit any false/ fake / doctored documents, then the contract will be cancelled with immediate effect.
- (vii) Deployment of operator, helper, supply of HSD, lubricants and maintenance of Excavator will be on account of the agency.
- (viii) The hour meter of Excavator should be in running condition. If the hour meter will not run then the Excavator will be treated as under breakdown condition. The hour meter reading must be noted in the log book which should be certified/ signed by the concerned supervisor / mines manager in daily basis.

2. Period of Contract- The contract period will be for 200 hours with a maximum of 08 hours/day from the date of issuance of Work Order.

3. Payment Terms-

- (i) The agency will submit one bill after completion of work.
- (ii) TDS & other deductions if any, will be made from the bill. Payment will be released within 30 days of receipt of duly approved bill.
- (iii) The payment shall be made after completion of the job subject to submission of the final bill and certified working log book.
- (iv) Statutory deductions as applicable will be made from the bill of the agency.
- (v) Bill will be certified by Sr. Manager (Mines) & approved by Business Head, BSLC.

4. **EMD:-**The EMD of Rs 5,000/- (Rupees five thousand only) should be deposited either in **cash** or in shape of crossed Demand Draft drawn in favour of “ The Bisra Stone Lime Company limited” payable at Birmitrapur/Rourkela to be enclosed.

5. **Penalty:-** In case of breakdown of Excavator the agency should repair within two hours, failing which the agency may arrange one alternative Excavator with proper valid documents for this job otherwise the penalty will be recovered @ Rs. 300/- per hour in a day maximum up to Rs. 2,000/- per day.

6. Other conditions:-

- (i) The participating agency should not have any litigation with BSLC.
- (ii) The price quoted shall be inclusive of HSD, lubricants and maintenance of Excavator
- (iii) BSLC reserves the right to close the contract at any time without assigning any reason. No compensation shall be payable on this account.
- (iv) The agency will be responsible for compliance of all statutory provisions, maintenance statutory records and payment of statutory dues in time. If any penalty claims by statutory authority due to non compliance of statutory provisions, then it will be charged in the account of the agency.
- (v) The Agency will be held responsible for payment of compensation owing to an accident occasioned during or any connection with this job.
- (vi) The agency will provide safety equipments to his employees engaged for this job.
- (vii) No escalation in rate shall be entertained during the contract period.

7. ARBITRATION:-

Any dispute or difference under or arising out of or in respect of the Agreement/Accepted Contract may be referred to the sole Arbitrator, a person appointed by the Managing Director, The Bisra Stone Lime Company Limited, RINL, Visakhapatnam, Andhra Pradesh and his decision in the matter will be final and binding on the contractor and the Company. The arbitration shall be carried out as per Arbitration Act, 1996 and Rules made there under as amended from time to time.
