GENERAL TERMS & CONDITION  
Chapter - II

Sealed Tenders in prescribed format are invited from the experienced agencies for supply of Four (04) Nos. Diesel driven cars: Indigo (eCS) / Desire (Tour) and One (01) No. Diesel driven car: Etios on monthly basis to The Orissa Minerals Development Company Limited (OMDC).

1. Scope of Work :

- a) Supply of Four (04) Nos. Diesel driven cars: Indigo (eCS) / Desire (Tour) and One (01) No. Diesel driven car: Etios on monthly basis.(exclusive of one day weekly off and National Holiday)
  - b) The vehicle will be used for local duties at Kolkata / West Bengal as well as for other duties outside Kolkata / West Bengal.
  - c) Vehicles shall be made available during the calendar month 12 Hours per day.
2. Period of Contract: Four years w.e.f. 01.09.2016 or from the date of issue of LOI, whichever is later.

The contract will be initially for a period of 4 (four) years. The contract period may be extended for a period of further 1(one) year subject to the satisfactory performance at the sole discretion of the management of OMDC.

1. Eligibility Condition for technical bid :

In order to qualify in the tender, the tenderer must produce the following :

- (a) Proof of ownership of Four (04) Nos. Diesel driven cars: Indigo (eCS) / Desire (Tour) and One (01) No. Diesel driven car: Etios or undertaking to produce the same within 15 days of award of contract, upon which only LOI will be issued.
- (b) The vehicles be supplied should be in good running condition and not be older than 2011 and must fit to ply on road as per all statutes including Pollution check.
- (c) The party shall give a written undertaking that the vehicles shall be made available all days in road worthy condition failing which any expenditure incurred by the Company due to break-down of the vehicle or for any other reason shall be recovered from the Party by deducting from his bills.

- (d) EMD to be provided @ Rs.10,000/- by Bank Draft for each vehicle from a Nationalised Bank in favour of "The Orissa Minerals Development Company Limited", at Kolkata. The same Bank Guarantee will be released within 3 months from the date of issue of LOI .

2. Other Terms and Conditions :

- (a) Offer shall be quoted on monthly basis (exclusive one day weekly off and National holiday) inclusive of Service Tax.
- (b) Offer shall be quoted for fixed hire charges in respect of one calendar month for a fixed Kms of distance upto 2400 Kms or 7200 Kms in a quarter . In case the vehicle is used for more than 7200 Kms in a quarter (3 months) (quarter shall be counted from the date of issuance of work order ), the party shall be paid for the extra Kms running in excess for the respective quarter as per agreed rates.
- (c) Fuel & Lubricants for the cars shall be provided by the party and at the cost of the Party.
- (d) Drivers of the cars shall be provided by the party and at the cost of the party.
- (e) Repair and Maintenance shall be carried out by the party at his cost.
- (f) Night halt charges shall be paid by the Company @ Rs.100/- per day on outside duty.
- (g) Over Time will be provided by the Company on hourly basis beyond 12 hours per day.
- (h) The vehicles should have valid Registration Certificate, up-to-date Road Tax payment Insurance Certificate etc. The driver should have valid driving license. The offer will be considered normally on lowest rate basis. However, Company reserves the right not to accept the lowest offer. The Company also reserves the right to cancel the part or whole of the Tender without assigning any reasons thereof.
- (i) The Company reserves the right to terminate the contract by giving 30 days notice without assigning any reason whatsoever.
- (j) In case of breakdown of vehicles or non availability of vehicles or refusal by drivers to run vehicles even after 12 hours duty, alternate arrangement will be made by OMDC and the cost of hire at market rate will be recovered from your bills.
- (k) Compliance of all statutory obligations shall be ensured by the agency. The agency shall indemnify OMDC Ltd. against any liability failing on OMDC Ltd. due to non-compliance statutory obligations by the agency or any of its agent / servants / drivers or any reason whatsoever.

5. Evaluation of the Bids :

- i) The Part-I Techno-commercial bid: Parties, who will fulfill all the requisite conditions of the eligibility criteria of the tender document, will be construed as technically qualified and may be considered for Part-II Price Bid.
- ii) The Price Bid of technically qualified party will be treated as L-1 , if the rate quoted by such bidder for Part-II (Price Bid), is the lowest among all the technically qualified bidders.

6. Award of Contract :

- i) Notwithstanding above. the Company reserves the right to accept or reject the tender without assigning any reason thereof.
- ii) Award of Contract shall be made at the absolute discretion of OMDC. The Company reserves the right to reject/cancel any part or whole of the tender without assigning any reason whatsoever. For such cancellation the bidder shall not be entitled to claim any cost, expenses incidental to or incurred by him/her without assigning any reason whatsoever.
- iii) OMDC reserves the right to reject any or all offers without assigning any reason to the tenderers.

7. Payment & Settlement of bills :

- iii) Payment shall be made within 30(thirty) days from the date of receipt of the bills.

8. Deployment of Vehicles :
