Mines area shall be supported with suitable sump for collecting rain water and / or any seepage or percolation of ground water. The Contractor shall be responsible for De watering of waterlogged quarries in the mining areas by installing suitable capacity Pumps along with suction & delivery accessories at their own cost as per requirement.
