II. Amendment of clause no. 1.1 a) of eligibility criteria in Annexure-1 of NIT

Amendment clause to be read as below:

Experience of having successfully executed/competed during last 5(Five) years ending last day of month previous to the one in which NIT issued should be:

- At last 3500 mt. of core drilling and associated work in each of the completed work for 02 (two) nos. core drilling work.
- Preparation of at least one G1 level detailed Geological Report (GR) work costing not less than Rs.2,00,000,00/- (Two crores only) for any of the above submitted completed work.

III. Deletion of clause 1.2.10 of scope of work (Drilling work) in Special conditions of contract.

Geophysical data interpretation and analysis is DELETED.

IV. Inclusion of new para in clause (2) of NIT (Earnest Money Deposit)

The Small Scale Industries (SSI)/MSME Industries registered with Industries Department, Government of Odisha or the National Small Industries Corporation Ltd. (NSIC) or MSME registered

with Department of MSME, Govt. of India is exempted from submission of Earnest Money Deposit and Security Deposit and shall submit a self-attested copy of the Permanent Registration Certificate of their Small Scale Industries council along with their Tender. The SSI, MSME and NSIC who are registered for the particular trade /item, for which this Tender is relevant, will be exempted from submission of Earnest Money Deposit and Security Deposit. Such industries with their Provisional / Temporary Registration and not registered for the particular trade/ item for which tender is being invited would not be eligible for exemption.

V. Amendment of clause 1.3.1 a) & b) of service requirement including technical parameters of SCC.

The term (DGPS/Total station) to be read as only DGPS.

VI. Amendment of SL No. 4 of Bill of Quantities (BOQ) in Annexure-8 of NIT
